ROW and Common Land update

88/20 The Clerk advised that she continues to receive reports of dangerous stiles and blocked rights of way. The landowners have been contacted, along with subsequent reports to Wiltshire Council Rights of Way as necessary. When safe and practicable it was agreed to ask for volunteers for a ROW working party to be formed.

To note that due to HM Government's measures for Covid-19 no Annual Parish Meeting is able to be held and to resolve to approve that this be deferred until March 2021
